Justo Vizcarra (...) to appoint him Scribe of the Chamber of the Superior Court of the Department of Cuzco] The printed form contains the ordinance and mandate, as well as the topical and chronological data, in handwritten form: [Given at the Government Palace in March on 31 May 1839. 18<sup>th</sup> year of the Independence and 16<sup>th</sup> of the Republic.]. The blank spaces are handwritten in ink, in cursive letters linked to the right (uppercase - lowercase). The signatures and topical data are also handwritten in ink. In the lower left part of the document, there is a chalcographic seal of the Republic of Peru, on the right side the signatures of Agustín Gamarra and Manuel del Rio. At the bottom the purpose of the document. In the verso side: It presents two records, each with their respective signatures: First record: [Municipality of the Department of Cuzco 5 June 1839 / To be executed: acknowledge in the Administration of the Public Treasury; and it is declared to the interested party, prior to the proceedings foreseen in the Supreme Order of 3 of this month]. Second record: [Acknowledged in page 193 of the Book of provisions of this Administration of the (illegible) Cuzco 8 June 1839 / Pozo (signature)].

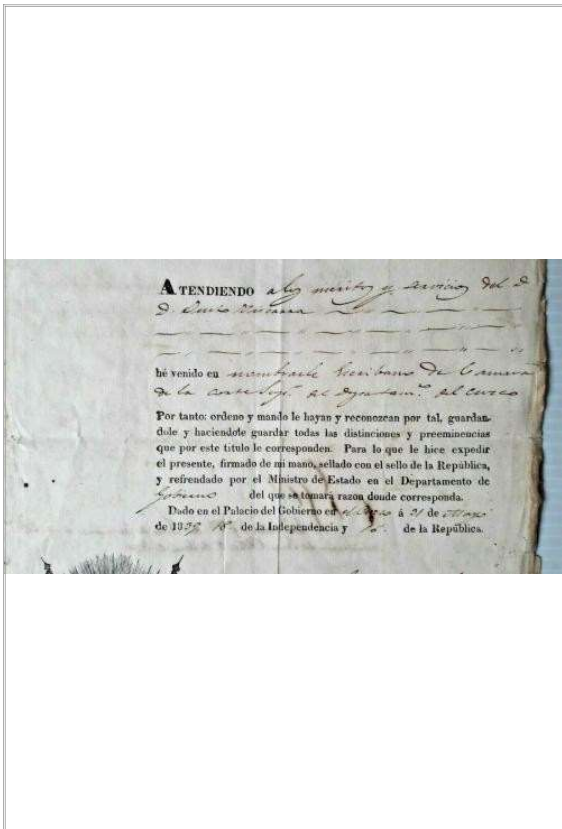


Image: Front detail, upper part.

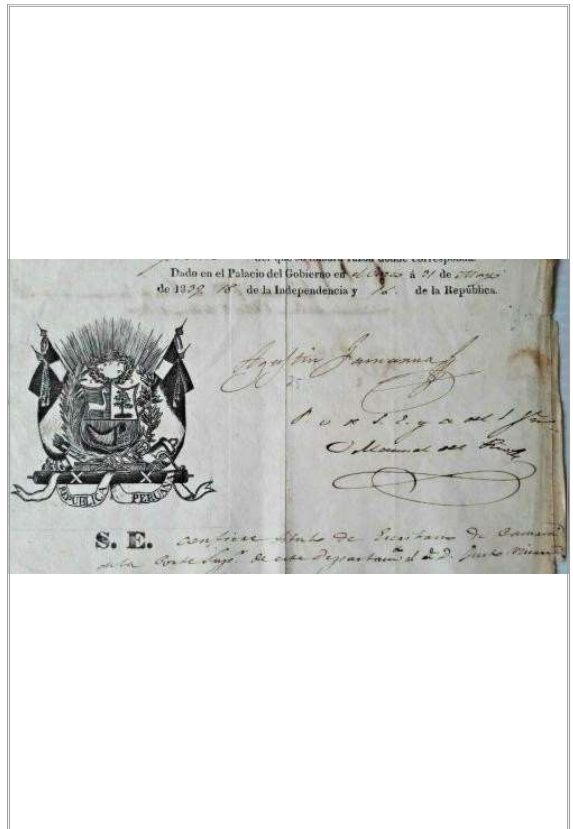


Image: Rear detail, lower part.

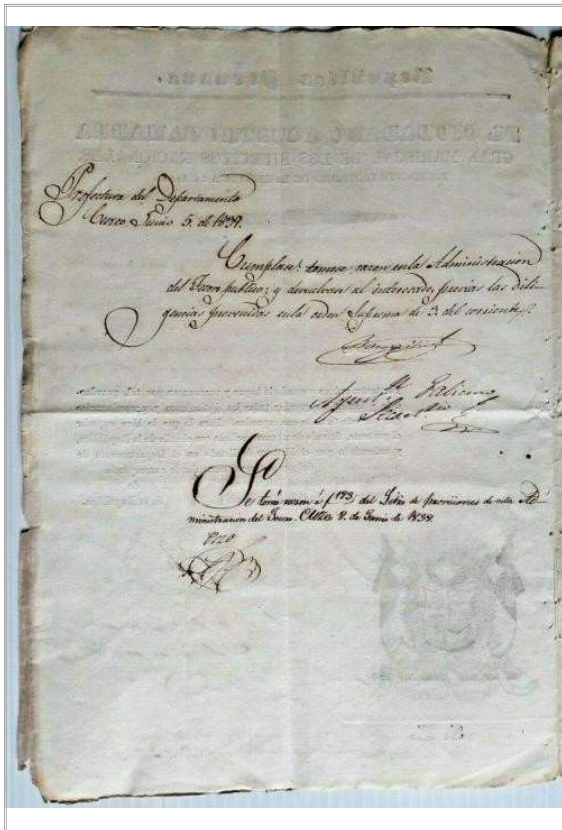


Image: Detail of the rear.
